

International Education Centre Photography Competition 2024 - Contest Rules

Contest Rules

The “Go Global with AC Photography Competition” contest (the “Contest”) is run by the International Education Centre at Algonquin College (the “College”). The Contest will run online from November 11, 2024, until November 29, 2024, at 11:59 pm EST (midnight).

Entries to the Contest must be submitted by November 25, 2024, at 11:59 pm EST (midnight).

The winner of the Contest will win a \$150 Gift Card for Air Travel (the “Grand Prize”). Second prize will be a brand-new carry-on luggage (valued at \$100) and third prize will be a brand-new weekender travel bag (valued at \$75).

Eligibility

Contest participants must be currently enrolled as a student at Algonquin College. Contestants must have participated in an international mobility experience in the last 2 years. (GSO funded trip, Work Integrated Learning: co-op, international placement, faculty-led trip etc.) Contestants must reside in Canada. Contestants cannot be current employees of Algonquin College.

Prizes

- 1st place: \$150 Gift Card for Air Travel
- 2nd place: Brand-new carry-on luggage (valued at \$100)
- 3rd place: Brand-new weekender travel bag (valued at \$70)

The prize has no cash redemption value.

Agreement to Be Legally Bound by Contest Rules

By submitting an entry in the Contest, an entrant has agreed that he, she or they have read and agrees to be legally bound by these Official Contest Rules and Regulations (the “Contest Rules”).

How to Enter

There is no fee to enter the Contest and no purchase is necessary. The Contest may be entered online only, by completing the online entry form in full and meeting all other contest entry requirements located at algonquincollege.com/international/international-education-week (“Contest Website”) within the Contest Period (the “Entry Form”). Contest entries received by any other method will not be accepted.

The entrant is responsible for ensuring meaningful consent was obtained for photographs of individuals other than the entrant.

To successfully complete an Entry Form, entrants must:

1. Enter all required information in the form.

2. Submit a photo!
3. Signify agreement that the entrant has read and agrees to be legally bound by these Contest Rules.

The entrant must follow all on-screen instructions to complete the Entry Form (once successfully completed, an "Entry").

An International Education Centre staff member (the “Reviewer”) will initially review every entry. Any entry that the Reviewer deems, in its sole and absolute discretion, to violate the terms and conditions set forth in these Contest Rules will not be posted.

To be eligible for the Grand Prize: the entrant and the Entry must comply with these Contest Rules and be submitted and received by the College in accordance with these Contest Rules during the Contest Period.

All materials relating to the Entry will hereinafter be referred to as the “Entry Materials”, must comply with these Contest Rules. Any Entry or Entry Materials, as determined by the College at any time in its sole and absolute discretion, that do not comply with these Contest Rules or meet the eligibility requirements will be discarded and will not be eligible for entry in the Contest will be discarded or, if selected in the draw, shall be rejected. Late entries will be disqualified.

Entry Limit

There is a limit of one (1) Entry per person. If it is discovered by the College that any person has attempted to use multiple names, multiple identities, multiple email addresses, any automated, macro, script, robotic or other system(s) or program(s) and/or any other means not in-keeping with the College’s interpretation of the letter and spirit of these Contest Rules to enter or otherwise participate in or to disrupt this Contest; then that person may be disqualified from the Contest in the sole and absolute discretion of the College.

The College and its agents, employees, directors, successors, and assigns (collectively, the “Released Parties”) are not responsible for lost, incomplete, late, incompatible or misdirected entries or for any failure of the Contest Website during the Contest Period (whatever the cause may be), or for any technical malfunction, and will not be liable for any resulting injury or damage to any person or property arising from, or relating to, that person’s or any other person’s participation or attempted participation in the Contest, or attempted voting in the Contest.

Warranties and Representations

By participating in the Contest, each entrant hereby warrants and represents that the Entry Materials he, she or they submit:

- a. is original and that the entrant has obtained all necessary rights in and to the Entry Materials for the purposes of entering such Entry Materials in the Contest.
- b. does not violate any law, statute, ordinance or regulation.
- c. does not contain any reference to or likeness of any identifiable third parties, unless consent has been obtained from all such individuals and their parent/legal guardian if they are under the age of majority in their jurisdiction of residence.
- d. will not give rise to any claims whatsoever, including, without limitation, claims of infringement, invasion of privacy or publicity, or infringe on any rights and/or interests of any third party; and

e. is not defamatory, trade libelous, pornographic or obscene, and further that it will not contain, depict, include, discuss or involve, without limitation, any of the following: nudity; alcohol/drug consumption or smoking; explicit or graphic sexual activity, or sexual innuendo; crude, vulgar or offensive language.

and/or symbols; derogatory characterizations of any ethnic, racial, sexual, religious or other groups (including, without limitation, any other colleges or universities); content that endorses, condones and/or discusses any illegal, inappropriate, risky or dangerous behaviour or conduct; personal information of individuals, including, without limitation, names, telephone numbers and addresses (physical or electronic); commercial messages, comparisons or solicitations for products or services other than products of College; any identifiable third party products, trade-marks, brands and/or logos, other than those of the College (clothing worn and/or products appearing in your Entry Materials must not contain any visible logos, trade-marks or other third party materials unless the appropriate consents have been obtained --- note: all identifiable third party products, trade-marks, brands and/or logos for which consent has not been obtained by the entrant must be blurred out so as to be unrecognizable); conduct or other activities in violation of these Contest Rules; and/or any other materials that are or could be considered inappropriate, unsuitable or offensive, all as determined by the College in its sole and absolute discretion.

Grand Prize Award Process

Entries must be submitted by November 25, 2024, at 11:59 pm. On November 26, a jury of Algonquin College Staff (including student staff) will be provided with all submissions to review and select the top photos (between 10 and 20 submissions) based on the following selection criteria: relevancy, composition, creativity, technical quality, and overall impression.

The top submissions will be placed on the International Education Centre website and Algonquin College community members (individuals with a @algonquinlive or @algonquincollege email and valid ID number) will be able to vote online from November 20 until November 26 at 11:59 pm EST. The photograph with the most votes will win the grand prize. The second and third place prizes will be awarded to the entrants receiving the second and third highest number of votes.

The contest winner will be notified on **November 29, 2025** and must complete and sign the College's form of Declaration of Eligibility and Release, and return it to ac-overseas@algonquincollege.com.

Disqualification: If any one of the contest conditions is not met, the selected entrant will be disqualified and shall not be entitled to receive any prizes. The International Education Centre has the discretion to verify the information provided in the student's entry form. If any information is determined to be false, the International Education Centre reserves the right to disqualify that entrant. There is no right of appeal for decisions made by the International Education Centre.

General Terms and Conditions

All entrants, Entries and Entry Materials are subject to verification by the College at any time and for any reason. The College reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility and/or compliance with these Contest Rules (in a form acceptable to the College – including, without limitation,

government issued photo identification):

- a. for the purposes of verifying an individual's eligibility to participate in this Contest and eligibility to be awarded the Grand Prize.
- b. for the purposes of verifying the eligibility and/or legitimacy of any Entry, Entry Materials, vote and/or any other information entered (or purportedly entered) for the purposes of this Contest; and/or Failure to provide such proof to the complete satisfaction of the College within the timeline specified by the College may result in disqualification in the sole and absolute discretion of the College. The sole determinant of the time for the purposes of this Contest will be the official time-keeping device(s) used by the College.

Any incomplete or fraudulent entries will be rejected. Any entrant or other individual who enters or attempts to enter the Contest in a manner which is contrary to the Contest Rules or which is otherwise disruptive to the proper operation of the Contest or by its nature is unjust to other entrants or potential entrants will be rejected and that entrant or purported entrant will be disqualified. All decisions of the College, with respect to any and all aspects of the Contest, including without limitation the eligibility or disqualification of entrants or entries, are final and binding without right of review or appeal.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Contest Rules or the rights and obligations of entrants, the College or any of the other the Released Parties in connection with the Contest will be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. All parties hereby consent to the exclusive jurisdiction and venue of the courts located in Ottawa, Ontario in any action relating to these Contest Rules or this Contest.

The College reserves the right, in its sole and absolute discretion, to modify, cancel, terminate, or suspend (collectively, "Change") the Contest, in whole or in part, in the event of any cause or circumstance whatsoever with or without notice. Such Change may be made whether the cause of the Change was within the College's control or not, including due to any virus, computer bug or unauthorized human intervention, unauthorized or automated voting, or any other cause that is beyond the control of the College, that could corrupt or affect the administration, security, impartiality or normal course of the Contest. In no event shall the College be liable to an entrant or any third party in connection with any such Change.

By entering or attempting to enter the Contest, each entrant and/or purported entrant agrees:

to release, discharge, and forever hold harmless the Released Parties from any and all claims, actions, damages, injuries, demands, manner of actions, causes of action, suits, debts, duties, accounts, bonds, covenants, warranties, indemnities, claims over, contracts and liabilities of whatever nature or kind arising out of, or in connection with the entrant's participation or attempted participation in the Contest, compliance or non-

compliance with these Contest Rules and acceptance and use of the Grand Prize any portion thereof; and

a. if selected as a Grand Prize winner but before receiving a prize, to sign the College's form of Declaration and Release giving the College permission to publish in print, broadcast or online, the winner's name and likeness without remuneration.

By entering the Contest and submitting an Entry, each entrant:

b. grants to the College, in perpetuity, a non-exclusive license to publish, display, reproduce, modify, edit or otherwise use his or her Entry Materials, and identity including name and photograph (and each component thereof), in whole or in part, for advertising or promoting the Contest or for any other reason.

c. waives all moral rights in and to his or her Entry Materials (and each component thereof) in favour of the College (and anyone authorized by the College to use such Entry Materials); and

d. agrees to release and hold harmless the Released Parties from and against any and all claims, damages, liabilities, costs, and expenses arising from use of his or her Entry Materials (or any component thereof), including, without limitation, any claim based on publicity rights, defamation, invasion of privacy, copyright infringement, trade-mark infringement or any other intellectual property related or other cause of action whatsoever.

The winner must sign a release form, giving Algonquin College the permission to publish in print, broadcast or online, the winner's name without remuneration.

Personal Information and Privacy: By entering this Contest, each entrant expressly consents to the College, storing, sharing and using the personal information submitted for the purpose of administering the Contest and in accordance with College's privacy policy (available at: <https://www.algonquincollege.com/policies/privacy>). This section does not limit any other consent(s) that an individual may provide the College or others in relation to the collection, use and/or disclosure of their personal information.
