Page Description	Draw Down	Example
Simple Page	\$10	Page contains mostly text: paragraphs, lists, bullets, may include an image or two.
Page with one or more tables	\$12	Page contains one or more tables. If only one simple table, simple page rate may apply.
Page with Form Fields	\$20 or \$2.50 per field	Page contains one or more fillable form fields. Pages containing form fields are drawn down at the higher of \$20 per page or \$2.50 per field.
Complex Page	\$22	The page includes a number of math equations, complex charts, complex graphs or complex tables.

Our Process

Before beginning work, we complete a review of the document, detail our approach, and verify delivery to ensure the timeframe meets your needs.
